GENERAL RELEASE

The undersigned group/organization (hereinafter "Participant"), for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, hereby waives and releases Celebration of Texas Independence Day, Inc., their Board of Directors, Officers, volunteers, members, employees, representatives and designated officials in both their official and individual capacities ("The Released Parties") from all claims including, but not limited to, tort claims, property damage, breach of contract, fraud, negligence, gross negligence, Deceptive Trade Practices, personal injuries or death arising from Participant's participation in this year's Texas Independence Day Parade and Celebration in Austin, Texas on March 5th, 2022. By signing below, the signatory understands that this is a complete and final releases in full of every claim of whatsoever kind or nature, whether past, present, or future, which Participant or it's heirs, executors, administrators, legal representatives, officers, directors, shareholders, employees, successors, volunteers or assigns might now or hereafter make against the Released Parties, arising out of or in any way connected with Participant's participation in this year's Texas Independence Day Parade and Celebration in Austin, Texas on the scheduled date. By signing this Release the undersigned signatory hereby represents and warrants that he/she:
